This chapter includes a glossary of valuation terminology, a discussion of the three primary methods used in the valuation process for a business entity, and a discussion of valuation techniques used in determining fairness. The author also treats recent decisions dealing with leveraged takeovers occurring in the late 1980s, and the related recapitalizations, restructurings, exchange offers and bankruptcies of the 1990s.
